Amendment #1 of 2008

Traffic Rules and Regulations of the Village of Croton on Hudson issued pursuant to Section 215-21 Parking Prohibited Certain Hours

Section 215-63 Schedule XV: Parking Prohibited Certain Hours of the Vehicle and Traffic Law is hereby amended as follows:

- A. The parking of vehicles is hereby prohibited at the following locations between the hours of 4:00 a.m. and 6:00 a.m. on the following days of the week, except if a legal holiday falls on one of those days:
1. Grand Street, on the north side on Monday, from the intersection of Maple Street and extending to the intersection of Old Post Road North.
 2. Grand Street, on the south side on Thursday, from the intersection of Old Post Road North and extending to the intersection of Maple Street.
 3. South Riverside Avenue, on the east side on Tuesday, from Benedict Boulevard and extending to Oneida Avenue.
 4. South Riverside, on the west side on Friday, from a point opposite the intersection of Oneida Avenue and extending to Benedict Boulevard.
 5. Old Post Road South, on the east side on Monday, from the intersection of Maple Street and extending to the intersection of Grand Street.
 6. Old Post Road South, on the west side on Thursday, from the intersection of intersection of Grand Street and extending to the intersection of Maple Street.
 7. Riverside Avenue, on the east side on Tuesday, from the intersection of Grand Street extending North to the intersection of Prospect Place.
 8. North Riverside Avenue, on the west side on Friday from the Route 9 Northbound exit ramp extending south to the point opposite to the intersection with Brook Street.
 9. Asbury Methodist Parking Lot on Monday.
 10. Brook Street, on the north side, on Tuesday, from the intersection with Old Post Road North and extending West to the intersection with Terrace Place.
 11. Merwin Oak Parking Lot on Thursday
 12. Brook Street, on the south side, on Friday, from 640 feet East of Riverside Avenue extending east to the intersection with Old Post Road North.
- B. The parking of vehicles is hereby prohibited at the following locations between the hour of 7:00 a.m. and 7:30 a.m. on the following days of the month, except if a legal holiday falls on one of those days:
1. Old Post Road South, on the on the east side, on the first Monday of every month, from 650 feet South of Maple Street extending North to the intersection of Maple Street.

2. Old Post Road South, on the west side, on the first Thursday of every month, from the intersection of Maple Street extending 650 feet South of Maple Street.
- C. The parking of vehicles is hereby prohibited at the following locations between the hours of 9:00 a.m. and 11:00 a.m. on the following days of the month, except if a legal holiday falls on one of those days:
1. Grand Street, on the North side, on the first Monday of every month, from the intersection with Old Post Road North to the intersection with Riverside Avenue.
 2. Maple Street, on the West side, on the first Tuesday of every month, from the intersection with Grand Street to the intersection with Old Post Road South.
 3. Grand Street, on the South side, on the first Thursday of every month, from the intersection with Riverside Avenue to the point opposite the intersection with Old Post Road North.
 4. Maple Street, on the East side, on the first Friday of every month, from the intersection with Old Post Road South to the point opposite to the intersection with Grand Street.
 5. Brook Street, on the South side, on the first Monday of every month, from the intersection with Riverside Avenue extending 360 feet to the east.
 6. Maple Street, on the West Side, on the first Thursday of every month, from the intersection with Old Post Road South to the intersection with Wells Avenue.

The above amendments to the Traffic Rules and Regulations shall become effective July 7, 2008.
